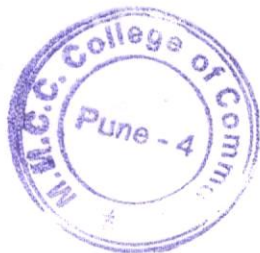

**Overview:**

The Fundamentals of Remote Sensing and Geographic Information Systems (GIS) Technology (Course in Hindi) Certificate Course was conducted by the IIRS ISRO MMCC Nodal Center during 14th Sept. to 28th Sep. 2021. The course aimed to provide participants with a comprehensive understanding of remote sensing principles, GIS applications, and their integration for various environmental and geospatial analyses.

**Objectives:**

- To introduce participants to the basic principles and concepts of remote sensing.



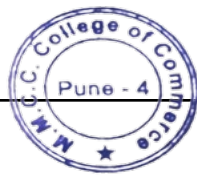

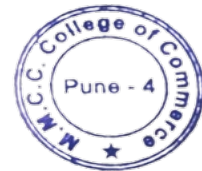


## Various activities undertaken in Apla Ghar Social Outreach Programme



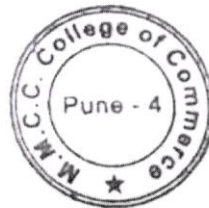

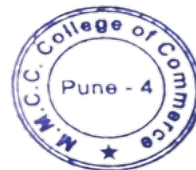
### Report on Inaugural ceremony of Accounting Museum

ICAI Pune is the first branch in India to set up such museums in five colleges, said CA Sameer Laddha.





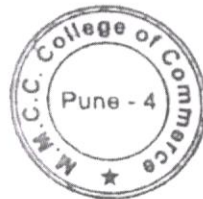

**Co-working Agreement**

This AGREEMENT is made and executed at Pune on 9<sup>th</sup> July, 2021; and shall be effective from 9<sup>th</sup> July, 2021. ( here in after referred to as "Effective Date").

BY AND BETWEEN

Foundation for MakeItHappen Center for Invention, Innovation and Incubation (MMCI) at Marathwada Mitramandal College of Engineering, S.No. 18, Plot No 5/3, CIS No 205, Behind Vandevi Temple, Karvenagar, Pune 411052 through its authorized representative Dr. Chandrashekhar Ramlal Talathi, CEO-MMCI, Age 60 years (hereinafter referred to as "MMCI" which expression shall unless repugnant to the context hereof, mean and include its present and future trustees, managing committee members, executors and administrators, assigns etc.)

...PARTY OF THE FIRST PART

AND

**Marathwada Mitramandal's College of Commerce (MMCC)** Located at 202/A, Deccan Gymkhana, Pune, Maharashtra 411004 (any of the representative of MMCC, designated by the Principal, MMCC).

...PARTY OF THE SECOND PART

Hereinafter "MMCI" and "Marathwada Mitramandal's College of Commerce (MMCC)" shall individually be referred to as "Party" and collectively be referred to as "Parties".



**WHEREAS:**

1. Marathwada Mitramandal College of Engineering, established in the year 2006, is a leading academic institute affiliated with Savitribai Phule Pune University.
2. Marathwada Mitramandal College of Engineering has taken a bold step forward in establishing the said MMCI by partnering with Science and Technology Park, Pune (STP) – a leading technology business incubator and Tata Technologies Ltd. (TTL) – a leading global engineering service provider. This MakeItHappen Center for Invention, Innovation and Incubation (MMCI) has following objectives:
  - a. Help innovators to develop new products
  - b. Promote technology start-ups
  - c. Provide high end industrial training to increase chances of good quality jobs
  - d. Provide co-working space for young entrepreneurs for promotion of start-ups
  - e. Provide strong mentorship to those who want to invent new products, services and processes and to those who want to set up their own companies
  - f. Provide support for IPR and technology management – patents, copyrights, design registration etc. and its commercialization
  - g. Create mechanism for access to risk capital to start-ups like Seed Funding, Angel Investment, Venture Capital, Private Equity etc.

The MMCI provides an ecosystem for enhancing skills among employable persons and to identify, promote and support start-ups and budding entrepreneurs to successfully setup new enterprises. The said MMCI is equipped to provide all start-up related facilities and services to enable entrepreneurs to fulfil their objectives (Hereinafter referred to as "the said facilities and services"). The said MMCI is located at **Marathwada Mitramandal College of Engineering, S.No 18, Plot No 5/3, CIS No 205, Behind Vandevi Temple, Karvenagar, Pune 411052**.

3. FACILITY USER is desirous to avail the said facilities and services at the said MMCI and have approached the said MMCI for permission to use the said facilities and services for the purpose of business.
4. MMCI has agreed to provide the said facilities and services to IIP on the terms and conditions mutually agreed between the parties and as mentioned hereunder.

Now therefore, this agreement witnessed and it is agreed by and between the parties as under:

**GENERAL TERMS AND CONDITIONS:**

**1. NATURE**

MMCI hereby grants its permission to FACILITY USER to use the said facilities and services for the Term and subject to the terms and conditions as agreed in this agreement.

**2. TERM**

This agreement shall commence on the Effective Date and shall remain valid for 1 (one) year from the Effective Date, unless terminated by the Parties as per the provisions of this agreement.

### **3. FACILITIES AND SERVICES TO BE PROVIDED BY MMCIII:**

MMCIII agrees to provide following facilities and services to FACILITY USER:

- 3.1. Co-working space (6 days a week except Sunday, from 08:00 AM to 08:00 PM comprising of:
  - 3.1.1. Number of co-working seats
  - 3.1.2. Cabin/Co-working space located on first floor of the building.
- 3.2. Use of Common areas such as waiting area, reception, pantry etc.
- 3.3. Shared use of conference room/discussion rooms with prior intimation.
- 3.4. Individual work table with power back up and shared Internet connection (to be used only for business communication).
- 3.5. Pay and purchase beverages from the vending machine in Pantry.
- 3.6. Preferred access to business training and information workshops.
- 3.7. Access to business services from our panel members at nominal cost.
- 3.8. Housekeeping support (only during normal working hours on normal working days) and vehicle parking (one two-wheeler per seat; four wheeler parking may be made available on request at additional charge).
- 3.9. MMCIII shall observe public holidays declared by Government of Maharashtra. However, to support FACILITY USER, MMCIII may decide to keep the space open on some of these holidays.

### **4. CONSIDERATION**

- 4.1. In consideration of the use of said facilities and services to be provided by MMCIII, FACILITY USER hereby agrees to pay to MMCIII consideration amounts as mentioned below:
  - 4.1.1. Rs. 1000/- (Rupees One Thousand Only) towards one time registration charges.
  - 4.1.2. Rs. 5000/- (Rupees Five thousand only) per month for 1 seat in Green Lake Island 1 for day shift (8.00 am to 8.00 pm)
  - 4.1.3. Additional Lockers will be charged extra.
  - 4.1.4. Applicable GST to be paid extra
  - 4.1.5. Team members beyond the number of seats hired will be considered as floating co-working seats and charged at the rate equal to 50% of fixed co-working seat charge, provided that number of floating co-working seats should not exceed twice the number of fixed co-working seats and at any given point in time there will only be as many team members as there are fixed co-working seats (except when there is overlap of shifts).
- 4.2. Allotment for more seats/office space for co-working to Facility USER at a future point of time will be considered subject to availability and in the sole discretion of MMCIII.
- 4.3. The consideration amount shall be payable in advance on or before the 5<sup>th</sup> day of month for which it becomes due. Any change in the said amount would be intimated to FACILITY USER prior hand.
- 4.4. MMCIII shall raise an invoice / bill of supply on monthly basis in favor of FACILITY USER.
- 4.5. In the event of any reduction in the number of seats/area allocated in a particular month by FACILITY USER; FACILITY USER is required to give an advance written notice of 1(one) month to MMCIII intimating such reduction in the number of seats/area allocated. If FACILITY USER fails to serve a written notice as mentioned herein, FACILITY USER hereby agrees to pay the consideration amount for the seats/area allotted to FACILITY USER before such reduction in the number of seats/area. No reduction in the number of seats/area availed will be allowed during any current ongoing month.
- 4.6. Any delay in the payment of monthly consideration amount by FACILITY USER will attract a penalty at an interest at the rate of 1.5% per month.
- 4.7. It is explicitly agreed between the parties that FACILITY USER shall bear and pay the other charges and expenses related for availing any extra facilities and services at the said MMCIII in addition to the list mentioned in clause 3.
- 4.8. FACILITY USER shall pay the consideration amount till such time as the charges are revised. Every year, the charges will be revised and communicated to FACILITY USER in the month of February. The revised charges shall be applicable from 1<sup>st</sup> day of April. Any other revision in charges shall be communicated to FACILITY USER at least 2(two) months in advance.

## **5. SECURITY DEPOSIT (Discretionary)**

- 5.1. FACILITY USER shall deposit and keep deposited with MMCIII an interest free refundable security deposit (Hereinafter referred to as "**Security Deposit**") which is equivalent to 2 (two) months consideration amount which is calculated on the basis of number of seats/sq.ft. of area allotted to FACILITY USER and paid by FACILITY USER to MMCIII, as a security to ensure the due fulfilment and observance of the terms and conditions contained in this Agreement. If there is an increase in the consideration amount due to increase in the number of seats/area allotted, FACILITY USER hereby agrees to deposit the increased differential amount of security deposit in addition to the previous security deposit amount kept with MMCIII, at all times. If there is a decrease in consideration amount due to decrease in the number of seats/area allotted, MMCIII hereby agrees to return the decreased differential amount of security deposit to FACILITY USER.
- 5.2. MMCIII will refund the Security Deposit (after making deductions with respect to unpaid amounts, damages to the said facilities and services etc., if any) to FACILITY USER within 1 (one) month after FACILITY USER hands over free, vacant and peaceful possession of the co-working space to MMCIII.
- 5.3. In case of any damage to the said facilities and services of MMCIII by FACILITY USER, MMCIII shall be entitled to deduct the same from the Security Deposit. In the event of Security Deposit falling short of the amount of damages caused, MMCIII shall have a right to demand FACILITY USER to make up the shortfall, if any, in the security deposit to the extent of the amount which has been borne by the MMCIII.
- 5.4. Security deposit is waved off for this agreement.

## **6. OBLIGATIONS OF FACILITY USER**

- 6.1. FACILITY USER shall use the said facilities and services at the said MMCIII strictly for the purpose of business and for no other purpose for the term as mentioned in this agreement.
- 6.2. FACILITY USER shall not be entitled to make any alteration to the said facility at the said MMCIII or any part thereof.
- 6.3. FACILITY USER shall permit MMCIII at all times to carry out inspection in the said office space at the said MMCIII.
- 6.4. FACILITY USER agrees that MMCIII shall not be responsible for any injury or loss to FACILITY USER or its personnel working at the said MMCIII due to any reason whatsoever.
- 6.5. FACILITY USER shall keep the said MMCIII and common space provided under the said facilities and services in neat and clean conditions and take proper care of the said facilities and services provided by MMCIII.
- 6.6. FACILITY USER agrees that the registration of FACILITY USER for the said facilities and services does not constitute a lease or sublease but is only a permission granted by MMCIII to use the said co-working space and the said facilities and services.
- 6.7. FACILITY USER shall not misuse any of the said facilities and services provided by MMCIII for any purpose other than mentioned in this agreement.
- 6.8. FACILITY USER agrees that the use of the said facilities and services by FACILITY USER shall not interfere with the interests of the other members/users of the co-working space.
- 6.9. FACILITY USER agrees not to maintain or store any inventory of goods in common areas of the said facilities and services without the permission of MMCIII.
- 6.10. FACILITY USER agrees not to act in a manner which in MMCIII's sole discretion does or is likely to adversely affect the peaceful operation or enjoyment of said facilities and services. FACILITY USER shall not engage in any illegal activity in the said CIII or in or around the Building.
- 6.11. FACILITY USER shall not sub lease / allow use of MMCIII by any third party.
- 6.12. FACILITY USER shall be fully and severely responsible for the safety and security of its assets and people.

## **7. CONFIDENTIALITY**

- 7.1. FACILITY USER agrees to keep confidential at all times any/all information or any proprietary information of MMCIII, whether of a technical nature or any other sensitive information, while using the said facilities and services. FACILITY USER shall hold all the information, data, material, instructions, communications, the terms and conditions of business as strictly confidential, whether comes to the knowledge of FACILITY USER through a written document or in oral form either through MMCIII or any other person or while due execution of this agreement. Further FACILITY USER shall not misuse MMCIII's confidential information during the subsistence of this agreement and for all time to come thereafter.
- 7.2. FACILITY USER shall maintain and use the confidential information only for such purpose as may be required and permitted for the due execution and performance of this agreement. FACILITY USER shall restrict access and disclosure of confidential information to third parties and shall use such information only on a "need to know" basis.
- 7.3. All confidential information shall, at all times, remain the sole and exclusive property of MMCIII.

## **8. INDEMNITY**

FACILITY USER shall indemnify and keep indemnified MMCIII and its successors in interest and title, assigns, agents, representatives and affiliates against, any claim, loss, damage, liabilities, costs and expenses (including, without limitation, reasonable attorneys' fees) incurred or sustained by reason of or arising out of any breach or alleged breach of the terms of this agreement by FACILITY USER and due to any acts, omissions, commissions, breach, default, negligence etc. by FACILITY USER.

MMCIII or any of its associates shall not be liable to pay any damage or compensation to FACILITY USER in the event of FACILITY USER's business failure or loss.

## **9. TERMINATION/EXPIRY**

- 9.1. This agreement shall automatically terminate on the expiry of the Term as mentioned hereinabove unless terminated earlier.
- 9.2. MMCIII shall have a right to forthwith terminate this agreement without any notice thereof, if FACILITY USER commits any breach or default of any of the terms and conditions of this agreement and/or commits a default in the payment of consideration amount as set forth in this agreement for a consecutive period of 2 (two) months.
- 9.3. Both the Parties shall have the right to terminate this agreement with reason thereof by issuing one (1) month's written notice to the other party of its intention to terminate its agreement.
- 9.4. In the event of termination of this agreement as per clause 9.1 above, MMCIII shall have a right to forfeit/adjust the arrears of the consideration amount from the Security Deposit. Further, FACILITY USER shall be liable to pay the liquidated damages and compensation to MMCIII and reasonable legal fees and other costs incurred by MMCIII on account of breach committed by FACILITY USER.

## **10. ARBITRATION**

In case any dispute or difference arises between the Parties as to any term and/or conditions of this Agreement, the Parties shall promptly meet and attempt in good faith to resolve such dispute or difference by amicable negotiations; Provided, that if the same is not so resolved within 30 days, the matter shall be referred to the sole arbitrator mutually appointed by the Parties. The arbitration proceedings shall be conducted in accordance with the Arbitration and Conciliation Act, 1996 and the venue of such arbitration shall be Pune, India only and the award or awards in such arbitration shall be final and binding on the Parties.

## **11. JURISDICTION AND GOVERNING LAW**

Subject to the arbitration clause, Pune court shall have exclusive jurisdiction in the matter. The provisions of this agreement or any other document entered between the parties herein shall be governed by and construed in accordance with Indian law.



## 12. ASSIGNMENT

FACILITY USER shall not be entitled to assign, charge, subcontract etc. any of its rights, title, interest or obligations under or in connection with this agreement to any person/third party.

## 13. NO THIRD PARTY RIGHTS

A person/entity who is not a party to this agreement shall not have any right to enforce any term of this agreement.

## 14. SEVERABILITY

Should any portion of this agreement be contrary to, or in violation and of no effect, the remainder of this agreement shall be valid and remain in force notwithstanding the invalidity of such portion.

## 15. AMBIGUITIES

Any ambiguous language in this agreement shall be interpreted as to its fair meaning, and not strictly for or against either party. Matters not provided for in this agreement shall be mutually decided by the parties, decision so agreed upon shall be final and binding on the parties.

## 16. AMENDMENT

The parties to this agreement may, add, delete, amend or alter all or any of the terms and conditions of this agreement as mutually agreed upon from time to time and such modification and changes shall not be effective until the same are in writing and duly signed by the authorized representatives of the parties.

## 17. NON WAIVER

No waiver, delay or failure by either party in enforcing any of the provision/s of this agreement shall prejudice or restrict the rights of such party under this agreement nor shall waiver by either party of any breach operate as a waiver of any subsequent breach. The rights, powers and remedies provided to each party in this agreement are in addition to, and do not exclude or limit, any right, power or remedy provided by law.

## 18. NOTICES

All notices and correspondence to either party shall be deemed to be properly served if sent to their respective addresses mentioned herein below, if sent by regular post mail, postage prepaid or commercial overnight courier. For enabling swift business communications, the parties shall provide their email addresses to expedite official correspondences and documents.



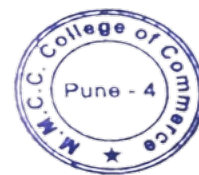

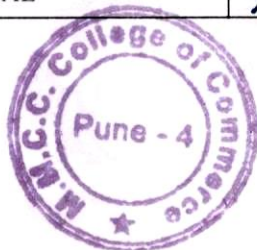

## Report On

### Unnat Bharat Abhiyan, MMCC

Unnat Bharat Abhiyan is a significant initiative of the Government of India aimed at driving rural development through the collaboration of higher educational institutions and rural communities. MMCC, with its vision of promoting quality education and sustainable development, has taken part in this flagship program by adopting five villages in Pune district: Ambi, Agalambe, Zalanwadi, Matalwadi, and Gorhe.

In these villages, a substantial portion of the community comprises residents, spinners, farmers, and farm laborers, with agriculture and complementary businesses being the primary sources of livelihood. While primary education facilities are available, there is a notable lack of interest in education among some backward communities, leading to a high dropout rate at the primary level. Many children are deprived of education as they accompany their parents to work in wage labor, rather than attending school.

To address these challenges, MMCC, as part of Unnat Bharat Abhiyan, has engaged with village stakeholders, including the Sarpanch, Gram Sevak, and other Panchayat members. The motto and objectives of the program were discussed with them, fostering an understanding of the shared goals. Additionally, a household survey was conducted to gain insights into the specific needs and requirements of the villages.

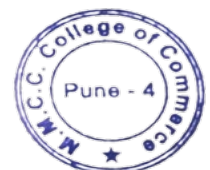
To improve healthcare in these rural areas, health camps were organized, providing primary health checkups for villagers and school children. Specific initiatives like breast cancer awareness and checkups were conducted in collaboration with hospitals.

Through these initiatives, students benefited from enhanced educational facilities and were exposed to issues prevalent in rural areas. The faculty members of MMCC have also played a crucial role in the success of the program, showing enthusiastic engagement and commitment to the cause.

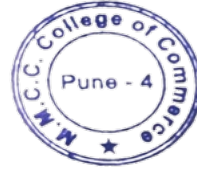

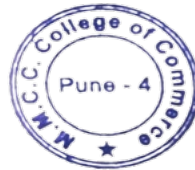

## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (“**MOU**”) is made at Pune and is executed on Tuesday, 07<sup>th</sup> December 2021 and shall be effective from the date mentioned herein as the effective date by and between:

**deAsra Foundation**, a not for profit company registered under Section 8 of the Companies Act, 2013, having its registered office at 101, Vanashree Apartment, 94/20 Erandwane, Prabhat Road, Lane No. 11, Pune – 411004 (hereinafter referred to as “**the Company**”, which expression shall unless repugnant, include its successors, assigns and authorized representatives);

AND

**Marathwada Mitra Mandal’s College of Commerce**, having its office at [202 / A, Deccan Gymkhana, Pune - 411 004, Maharashtra, INDIA ], (hereinafter referred to as the “**Partner**”, which expression shall, unless it be repugnant to the subject or context thereof, include its successors and permitted assigns).

The Company and the Partner shall collectively referred to as the “**Parties**” and individually as a “**Party**”.

### PURPOSE:

- A. The Partner is engaged in the activity “To impart quality education for professional excellence and sustainable development through continuous improvement, teamwork and efforts so as to promote welfare to all stakeholders”.
- B. The Company is engaged in the activity of helping new and aspiring entrepreneurs to start, manage and grow their businesses through a broad array of support services.
- C. The Parties may collaborate with each other by conducting webinars and such other activities as may be mutually agreed by the Parties. The candidates desirous of availing the Company’s services, tools and templates belonging to the small business sector may avail the Company’s services through its website [www.deasra.co.in](http://www.deasra.co.in) (“Company Platform”) in the manner as described hereinafter.

NOW, THEREFORE, in consideration of the mutual covenants and conditions herein set forth, the sufficiency of which is hereby acknowledged, the Parties agree to the following terms:

### 1. RESPONSIBILITIES OF THE PARTNER:

- a) The Partner shall collaborate with the Company for the conduct of webinars for the benefit of its target audience. The Partner shall arrange for the infrastructure and logistical support for hosting the webinars e.g. providing of zoom links etc.
- b) The Partner shall encourage its candidates to attend the Company webinars on such topics and at such fees as maybe mutually agreed by the Parties, however it will not be binding upon the partner to conduct any activity mandatorily.
- c) The Company would collect the required fees directly from the students, however if the

college proposes to conduct any activity, then the required payment will be made by the college for conducting the program, if any.

- b) The interested candidates of the Partner may avail the Company’s services, tools and templates as detailed in “Annexure A” and “Annexure B” respectively of this MOU (“**Company Services**”) at such fees and at such payment terms as maybe applicable at the time of availing these services. The interested candidates shall avail Company services by raising service requests on the Company Platform through an affiliate link provided to them for their existing or proposed business ventures. The Partner shall encourage its candidates to avail the Company Services and webinars solely at the discretion of its candidates. The Partner shall undertake this activity on best effort basis.
- c) The Partner may collaborate with the Company for exploring the possibilities of website integrations of both the Parties.
- d) The Partner may on a requisition made by the Company provide the Company with information, reports etc. pertaining to the subject matter of the MOU to the Company.
- e) The Partner may, after prior permission received from the Company use the logo of the Company on its website for the purpose envisaged in this MOU.

## 2. RESPONSIBILITIES OF THE COMPANY:

- a) The Company shall deliver the webinars on such topics and subjects as may be mutually agreed between the Parties.
- b) The Company shall deliver such webinars for such fees as maybe mutually agreed between the Parties
- c) The Company shall provide its Services to the eligible candidates of the Partner under this MOU subject to the payment by the candidates of the applicable Service Fees as maybe enforce at the time of availing the Company services by the candidates.
- d) The Company may on requisition made by the Partner, provide to the Partner the information about the status of the candidates and other updates regarding the progress of cases of its candidates through a dashboard link separately provided to the Partner.
- e) The Company may, after prior permission received from the Partner use the logo of the Partner on its website for the purpose envisaged in this MOU.

## 3. RELATIONSHIP OF PARTIES:

Relationship between the Parties to this MOU is that of an independent contractor, and nothing in this MOU will be construed to create a joint partnership, agency, or employer-employee relationship. Parties have the sole obligation to (i) comply with applicable laws and (ii) supervise, manage, contract, direct, procure, perform or cause to be performed its obligations set forth in this MOU, except as otherwise agreed upon by the Parties. Neither Party has an authority to make any commitment or representation for and on behalf of the other Party under this MOU.

## 4. SUBCONTRACT/ASSIGNMENT:

Neither Party shall assign, subcontract or otherwise transfer its rights or obligations under this MOU without prior written consent of the other Party, which will not be unreasonably withheld.

## 5. CONFIDENTIALITY:



- a) Unless otherwise specified in this MOU, both Parties agree to keep in confidence and not disclose to others, any knowledge, information and data (including the Module), furnished and claimed by either Party to be proprietary/confidential, provided such information is given in writing or, if oral, is reduced to writing within fifteen (15) days and such writing is marked to indicate the claims of ownership and/or secrecy. Both Parties agree that they shall not use, nor reproduce for use in any way, any proprietary information of the other except in furtherance of the relationship set forth herein.
- b) Both Parties agree to protect the proprietary information of each other with the same standard of care and procedures used by themselves to protect their own proprietary information of a similar nature and importance, but at all times using at least a reasonable degree of care.
- c) Upon the expiry of termination of this MOU, the Partner shall immediately return all the tangible and intangible copies of the Module in its possession to deAsra. If the Modules are not capable on being returned, the Partner shall destroy/ erase all copies of the Module (in whatever form) immediately.

## 6. LIMITATION OF LIABILITY

NEITHER PARTY SHALL BE LIABLE TO THE OTHER FOR ANY INDIRECT, SPECIAL, CONSEQUENTIAL OR INCIDENTAL DAMAGES; LOSS OF PROFITS, LOSS OF REVENUE OR LOST OPPORTUNITIES, HOWEVER CAUSED, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. SUBJECT TO THE FOREGOING, THE TOTAL LIABILITY OF EITHER PARTY ARISING UNDER THIS MOU SHALL NOT EXCEED INDIAN RUPEES TEN THOUSAND.

## 7. NON-SOLICITATION

Both Parties agree not to solicit, employ, and/or absorb, either directly or indirectly, any of the employees or representatives of the other Party, during the subsistence of this MOU and for a period of two (2) years from the expiry or termination of the MOU.

## 8. TERM AND TERMINATION:

- a) This MOU shall be valid for a period of three years from the Effective Date. The Parties may extend the term of this MOU on mutually agreed terms and conditions.
- b) The MOU may be terminated by either Party without cause upon sixty (60) days prior written notice to the other Party.
- c) Either Party may terminate the MOU, if other Party materially breaches the terms of the MOU, and such breach remains uncured even after thirty (30) days' of receipt of a notice from the other Party.

## 9. MISCELLANEOUS

- a) **NOTICES:** Any and all notices that either Party is required or may desire to give to the other Party hereunder, shall be given by addressing the communication to the address set forth at the start of this MOU, and shall be served by certified mail, electronic email or registered post. Any change to the abovementioned address shall be informed to other Party in writing, within thirty (30) days of such change.


- b) **WAIVER:** No delay or failure of either Party in exercising any right and no partial or single exercise of any right shall be deemed to constitute a waiver of that right or any other rights under this MOU.
- c) **FORCE MAJEURE:** Neither Party shall be liable for any failure or delay in fulfilling the terms of this MOU due to fire, strike, war, civil unrest, terrorist action, government regulations, acts of Nature or other causes which are unavoidable and beyond the reasonable control of the Party claiming force majeure.
- d) **GOVERNING LAW:** the Parties shall settle any disputes that may arise under this MOU amicably. This MOU shall be construed and governed by the laws of India. Any dispute which is not resolved amicably shall be submitted to the sole jurisdiction of the courts of law at Pune.
- e) **SEVERABILITY:** The provisions of this MOU shall be deemed severable, and the invalidity or unenforceability of any provision (or part thereof) of this MOU shall in no way affect the validity or enforceability of any other provision (or remaining part thereof).

#### 10. ENTIRE AGREEMENT

This MOU shall constitute the complete and exclusive agreement between the Parties respecting the subject matter. This MOU may only be varied by mutual agreement of the Parties in writing. This MOU supersedes all previous MOUs, any understanding or agreement between the Partner and deAsra, whether oral or written, regarding subject matter hereof.

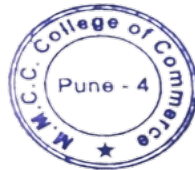
